ORDER

Sri A. Harinath has filed 2nd appeal dated 23-08-2022 which was received by this Commission on 27-08-2022 for not getting the information sought by him from the PIO / O/o. the Collector, Kongara Kalan, Ibrahimpatnam, Ranga Reddy Dist and 1st Appellate Authority / O/o. the Collector, Kongara Kalan, Ibrahimpatnam, Ranga Reddy Dist.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 26-06-2021 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

Kind attention is invited to the subject cited, that a representation letter is submitted to the District Collector, Ranga Reddy District regarding Survey of Grave Yard Land extent Ac.2-00 in Sy.No.7, Hyderguda (v), Rajendranagar (m), R.R.Dist., fix the boundaries and fencing in order to protect the said land from land grabbers. However, no action has been taken so far.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 02-02-2022 before the 1st Appellate Authority U/s. 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

Basing on the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 12-01-2023.

The case is called on 12-01-2023. The Appellant is absent. The Public Information Officer/ Sri M.Kranthi Kumar, Naib Tahsildar is present. The First Appellate Authority is absent.

The Public Information Officer submitted that information was furnished to the appellant vide Memo No. C/86/2022 dated 20-12-2022 under proper acknowledgment.
