ORDER

Sri CH.V.R.V. Prasada Rao has filed 2nd appeal dated 02-09-2022 which was received by this Commission on 02-09-2022 for not getting the information sought by him from the PIO / O/o. the Revenue Divisional Officer, Rajendranagar Division, Ranga Reddy Dist-500030 and 1st Appellate Authority / O/o. the Revenue Divisional Officer, Rajendranagar Division, Ranga Reddy Dist-500030.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 07-06-2022 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

1. Provide us the information, Names, and Designations of all the present permanent employees in the RDO OFFICE ?
2. Provide us the information on, Hierarchy system of your organization?
3. Provide us the information of one month's salaries and allowances of your permanent Officers & staff of your organization and also total expenditure?
4. Provide us the information, one-month expenditure, other than salaries & expenditure amount incurred by your organization?
5. Provide us the information regarding the total number of Contract/Outsourcing employees and also one-month expenditure incurred on them by your organization?

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 12-07-2022 before the 1st Appellate Authority U/s. 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

Basing on the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 27-01-2023.

The case is called on 27-01-2023. The Appellant is absent. The Public Information Officer/ Ms.Chandrakala, Revenue Divisional Officer is present. The First Appellate Authority is absent.
