ORDER

Sri M. Thirupathi Rao has filed 2nd appeal dated 02-09-2022 which was received by this Commission on 02-09-2022 for not getting the information sought by him from the PIO / O/o. the Tahsildar, Peddakothapally Mandal, Nagarkurnool Dist and 1st Appellate Authority / O/o. the Revenue Divisional Officer, Kollapur Division, Nagarkurnool Dist.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 13-05-2022 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 24-06-2022 before the 1st Appellate Authority U/s. 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

Basing on the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 09-01-2023.

The case is called on 09-01-2023. The Appellant is present. The Public Information Officer/ Sri M.Sreenivasulu, Administrative Officer is present. The First Appellate Authority is absent.

The Appellant submitted that he did not receive any information from the Public Information Officer.

The Public Information Officer submitted that the 6(1) application was not filed before their office and the same was filed before the Mandal Revenue Officer, Peddakothapally Mandal, Nagarkurnool District.

The Commission advised the appellant to approach the office of the Public Information Officer/ O/o. The District Collector, Nagarkurnool District along with a copy of the 6(1) application on any working day during office hours, who shall furnish the available and held information to the appellant , within two weeks thereafter.

In view of the above, the appeal is closed.
