

## **ORDER**

Sri A. Balreddy has filed a Complaint dated 05-09-2022 which was received by this Commission on 05-09-2022 for not getting the information sought by him from the PIO / O/o. the Tahsildar, Shankarpally Mandal, Ranga Reddy Dist.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **28-05-2022** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

The Public Information Officer has not furnished the information to the Complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission U/s. 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

Basing on the material papers available on record, the complaint was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 09-01-2023.

The case is called on 09-01-2023. The Complainant is absent. The Public Information Officer / Smt P.Priyanka, Naib Tahsildar is present.

The Public Information Officer submitted that available and held information is brought vide letter No.RTI/308/2022 dated 02-12-2022 to furnish to the complainant.

Since the complainant is absent, the Commission directed the Public Information Officer to furnish the above said information dated 02-12-2022 to the complainant forthwith through RPAD and report compliance to the Commission.

With the above direction, the complaint is closed.
