ORDER

Sri R. Srinivas Reddy has filed a Complaint dated NIL which was received by this Commission on 12-10-2021 for not getting the information sought by him from the PIO / O/o. the Chief City Planner, Greater Hyderabad Municipal Corporation, Head Office, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **09-08-2021** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

my neighbour constructing building in plot no. 211
(North part) Vanasthalihill, VANASTHALIPURAM. We have noticed
that building does not have proper C.M.C. permission
constructing in 2 plots with 1 plot permission. So, please
give me the information on this building as per
Right of Information Act.

- ① How many plots involved in this construction.
- ② What are the set backs as per sanction plan
and what are set backs maintaining now.
- ③ What are set backs needed as per construction area
of building and what are set backs maintaining now.
- ④ How much road affected area encroaching the construction
- ⑤ What is the total construction area allowed to built
as per sanction plan and what is the construction
are now going on. please give me the floor
wise information.
- ⑥ What is the action taken on this building for deviations.
- ⑦ What is the action taken for not taking any action if action
is not taken.

The Public Information Officer / O/o. the Chief City Planner, Greater Hyderabad Municipal Corporation, Head Office, Hyderabad vide Lr.No.R.720/RTI/TPS/HO/Greater Hyderabad Municipal Corporation,/2021/634, dated 03-09-2021 has transferred the RTI application U/s. 6(3) of the RTI Act to the Public Information Officer / O/o. the Dy. Commissioner, Greater Hyderabad Municipal Corporation, Circle 4, L.B. Nagar, Hyderabad to furnish the information directly to the Complainant under intimation to their office.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission U/s. 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

Basing on the material papers available on record, the complaint was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 09-01-2023.

The case is called on 09-01-2023. The Complainant is absent. Sri I.Veera Swamy, ACP is present on behalf of the Public Information Officer.

The representative of the Public Information Officer submitted that vide letter No.1701/641/RTI/TPS/C4/LBNZ/GHMC/2021 dated 07-09-2021, information was furnished to the complainant. He further submitted that vide letter No.102/RTI/TPS/C4/LBNZ/GHMC/2023 dated 09-01-2023, he has brought the information once again to furnish to the complainant.

Since the complainant is absent, the Commission directed the Public Information Officer to furnish the above said information dated 09-01-2023 to the complainant forthwith through RPAD and report compliance to the Commission.

With the above direction, the complaint is closed.
