## ORDER

Sri MD. Mushahed Ali has filed 2<sup>nd</sup> appeal dated 12-09-2022 which was received by this Commission on 12-09-2022 for not getting the information sought by him from the PIO / O/o. the Dy. Commissioner, Greater Hyderabad Municipal Corporation, Circle 20, Serilingampally, Ranga Reddy Dist-019 and 1<sup>st</sup> Appellate Authority / O/o. the Tahsildar, Serilingampally Mandal, Ranga Reddy Dist-019.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 19-05-2022 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

Sub:- Request to Issue Certified Xerox copies of **complete record** with covering letter from file with respect to **FTL boundaries limits and Mandal Revenue Survey No's and Lake Maps dimension details of FTL area** of Khajaguda and Nanakramguda of Serilingampally Mandal, Rangareddy District, Under RTI Act 2005.

3. Please provide the Certified Xerox copies from files with respect to
  1. Mandal Revenue Survey No's
  2. Lake / kunta Maps and Lake ID
  3. Dimension details of FTL Land and boundaries in **Khajaguda** area of Serilingampally Mandal, Rangareddy District.
4. Please provide the Certified Xerox copies from files with respect to
  1. Mandal Revenue Survey No's
  2. Lake / kunta Maps and Lake ID
  3. Dimension details of FTL Land and boundaries in **Nanakramguda** area of Serilingampally Mandal, R.R District

The Public Information Officer / O/o. the Dy. Commissioner, Greater Hyderabad Municipal Corporation, Circle 20, Serilingampally, Ranga Reddy Dist-019, vide Lr.No. C1/122/GHMC/2022, dated 24-05-2022 has transferred the RTI application U/s. 6(3) of the RTI Act to the Public Information Officer / O/o. the Tahsildar, Serilingampally Mandal, Ranga Reddy Dist-019 to furnish the information directly to the Complainant under intimation to their office.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 18-07-2022 before the 1<sup>st</sup> Appellate Authority U/s. 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get the information from the Public Information Officer / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The case is called on 12-01-2023. The Appellant is present. The Public Information Officer/ Sri G.Shanker, Naib Tahsildar is present. The First Appellate Authority is absent.

The Public Information Officer submitted that he has furnished the information to the appellant vide letter No. C/09/2022-82 dated 28-11-2022.

The Appellant submitted that he has received the sought information from the Public Information Officer.

Since information was furnished, the appeal is closed.
