ORDER

Smt. B. Neeraja has filed a complaint dated 23-09-2022 which was received by this Commission on 24-09-2022 stating that the Public Information Officer / O/o. the Tahsildar, Hayathnagar Mandal, Ranga Reddy Dist-501505 did not implement the Commission Order in Appeal No.6848/SIC-KSR/2021, dated 28-06-2022.

Stating that she did not receive any reply from the Public Information Officer, the complainant preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him U/s. 18(1) of the RTI Act, 2005.

Basing on the material papers available on record, the complaint was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 15-02-2023.

The case is called on 15-02-2023. The representative of the Complainant is present. The Public Information Officer/ Md. Shamshuddin, Naib Tahsildar is present.

The Public Information Officer submitted that vide Memo No.RTI/29/2020 dated 09-02-2023, the complainant was asked to visit their office during office hours and inspect the files, but the complainant did not turn up.

The representative of the Complainant submitted that the Public Information Officer has informed him that the sought record is not traceable in their office. He further submitted that the sought information infact is not available in the Office of the Public Information Officer, but the Public Information Officer instead of stating that the information does not relate to their office, is stating that the information is not traceable and he has proof to that extent.

Heard both sides and perused the material papers available on record.

Since the Public Information Officer has furnished a reply stating that the file is not traceable and also invited the complainant for inspection of records, the complaint is closed and the complainant can approach the appropriate Forum for redressal of his grievance, if so chooses, basing on the evidence available with him.
