## ORDER

Sri MD. Waheeduddin, Hyderabad-500024 has filed 2<sup>nd</sup> appeal dated NIL which was received by this Commission on 29-09-2022 for not getting the information sought by him from the PIO / O/o. the Tahsildar, Saroornagar Mandal, Ranga Reddy Dist and 1<sup>st</sup> Appellate Authority / O/o. the Tahsildar, Saroornagar Mandal, Ranga Reddy Dist.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **09-05-2022** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

I invite attention to the subject cited and request to provide me the certified copies of the following under R.T.I. Act 2005 pertaining to Dargah Hzt. Syed Shah Fakruddin Sabari, Masjid-e-Riyazunnissa Begum and Graveyard.

1. Copy of Pahanies of subject institution
2. Copy of Sethwar of subject institution
3. Copy of R.O.R. of subject institution
4. Copy of mutation of subject institution

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **18-08-2022** before the 1<sup>st</sup> Appellate Authority U/s.19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get the information from the Public Information Officer / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

Basing on the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 17-01-2023.

The case is called on 17-01-2023. The Appellant is absent. The Public Information Officer/ Sri Avanish Kumar Rai, Naib Tahsildar is present. The First Appellate Authority is absent.

The Public Information Officer submitted that the appellant, without mentioning any survey number in his 6(1) application, has sought the information, which is not specific and hence a reply was furnished to the appellant vide letter No.RTI/42/2022 dated 31-05-2022 .
