ORDER

Sri V. Ramchandar has filed a Complaint dated 01-10-2022 which was received by this Commission on 01-10-2022 for not getting the information sought by him from the PIO / O/o. the Tahsildar, Lingala Mandal, Nagarkurnool Dist-509401.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **21-02-2022** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

The Public Information Officer has not furnished the information to the Complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission U/s. 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

Basing on the material papers available on record, the complaint was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 27-01-2023.

The case is called on 27-01-2023. The Complainant is present. The Public Information Officer/Ms. Thaskin Mubeena, Naib Tahsildar is present.

The Public Information Officer submitted that she has furnished the available information to the complainant vide letter No.RTI/168/2022 dated 16-03-2022 and dated 24-01-2023. She further submitted that the pahanies relating to the year 2013-2014 are not available in their office and she has informed the same to the complainant.

P.T.O

The Complainant submitted that he did not receive the pahanies relating to the year 2013-2014 from the Public Information Officer.

Since available and held information was furnished, the complaint is closed.
