ORDER

Sri K. Srinivas has filed 2nd appeal dated 01-10-2022 which was received by this Commission on 01-10-2022 for not getting the information sought by him from the PIO / O/o. the Tahsildar, Kadthal Mandal, Ranga Reddy Dist-509358 and 1st Appellate Authority / O/o. the Revenue Divisional Officer, Kandukur Division, Ranga Reddy Dist-501359.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **25-06-2022** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

- ❖ మి కార్యాలయం మొత్తం పరిధిలో ప్రస్తుతం పనిచేస్తున్న శాశ్వత ఉద్యోగులలో ఏజెన్సీ రిజిస్ట్రేషన్ కోట ద్వారా ఉద్యోగాలు పొందిన ఉద్యోగుల యొక్క పూర్తి వివరాల సమాచారం ఇవ్వగలరు .
- ❖ అనగా సదరు ఉద్యోగులకు ఏజెన్సీ రిజిస్ట్రేషన్ కోట వర్తించిన సొంత ప్రాంత పూర్తి చిరునామా , మరియు పూర్తి పేరు , ఇంటి పేరు , తండ్రి పేరు , గ్రామం పేరు, మండలం పేరు , తాలూకా, pincode.
- ❖ డేట్ అఫ్ బర్త్ , జాబ్ లో చేరిన తేదీ , section చేసిన కార్యాలయ పూర్తి చిరునామా మరియు ప్రస్తుతం పనిచేస్తున్న కార్యాలయం పూర్తి చిరునామా మరియు ప్రస్తుత job హోదా , ప్రభుత్వం నుండి పొందుతున్న నెల వారీ జీతభత్యముల వివరములు .
- ❖ మరియు అందరి మీ కార్యాలయం మొత్తం పరిధి లోని ఏజెన్సీ ఉద్యోగుల యొక్క ఏజెన్సీ certificates నకలు (xerox) కాపీలు ఇవ్వగలరు.

The Public Information Officer has furnished the information to the appellant vide Lr.No.A/514/2022, dated 23-07-2022.

Since the appellant was not satisfied with the information received from the Public Information Officer, he filed 1st appeal dated **06-08-2022** before the 1st Appellate Authority U/s. 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant was not satisfied with the information received from the Public Information Officer and as he did not receive any response from the 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

Basing on the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 19-01-2023.
