ORDER

Sri K. Srinivas has filed 2nd appeal dated 01-10-2022 which was received by this Commission on 01-10-2022 for not getting the information sought by him from the PIO / O/o. the Tahsildar, Amanagal Mandal, Ranga Reddy Dist-509321 and 1st Appellate Authority / O/o. the Revenue Divisional Officer, Kandukur Division, Ranga Reddy Dist-501359.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **25-06-2022** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated **26-07-2022** before the 1st Appellate Authority U/s. 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

Basing on the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 19-01-2023.

The case is called on 19-01-2023. The Appellant is absent. Sri K.Jangaiah, Senior Assistant is present on behalf of the Public Information Officer. The First Appellate Authority is absent.

The representative of the Public Information Officer submitted that vide letter No. A/RTI/115/2022 dated 02-01-2023, information was furnished to the appellant through Registered Post.

The Commission has perused the above said letter dated 02-01-2023.

Since information was furnished, the appeal is closed.
