ORDER

Sri P. Janardhan Reddy has filed a Complaint dated 03-10-2022 which was received by this Commission on 07-10-2022 for not getting the information sought by him from the PIO / O/o. the Dist. Collector, Kongar Kalan, Ibrahimpattanam, Ranga Reddy Dist.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **27-06-2022** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points:

I, P. Janardhan Reddy S/o. P. Ananth Reddy, hereby request your Hon'ble Authority to furnish a copy of all documents in Appeal No: F1/IA-07/2012 (File No: F1/5281/2012) related to Sy.No. 177 situated in Solipur (V), Farooqnagar (M) between A. Chennaiah Goud & others vs Smt. Laxamma & others **under RTI Act, 2005**. The file is transferred from Joint Collector, Mahabubnagar to Joint Collector, Rangareddy after districts bifurcation.

The Public Information Officer has not furnished the information to the Complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission U/s. 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

Basing on the material papers available on record, the complaint was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 15-02-2023.

The case is called on 15-02-2023. The Complainant is absent. Smt K.Pramila Rani, Administrative Officer is present on behalf of the Public Information Officer.

The representative of the Public Information Officer submitted that she has brought the sought information vide Memo No.A5/RTI/17578/2022 dated 13-02-2023, to furnish to the complainant.

Since the complainant is absent, the Commission directed the Public Information Officer to furnish the above said information dated 13-02-2023 to the complainant forthwith through RPAD and report compliance to the Commission.

With the above direction, the complaint is closed.
