ORDER

Sri CH. Murali has filed 2nd appeal dated 10-10-2022 which was received by this Commission on 10-10-2022 for not getting the information sought by him from the PIO / O/o. the Tahsildar, Jinnaram Mandal, Sangareddy Dist and 1st Appellate Authority / O/o. the District Collector, Sangareddy, Sangareddy Dist.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **11-02-2022** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

1. Copy of list of resumption proceedings of agricultural land admeasuring Ac.2-20 guntas in Sy.No.144/9 situated at Kajipally Village, Jinnaram Mandal, Sangareddy district issued by the government of telangana state under pot act.
2. Copy of detailing of Pattadars of which extent resumed by the Government
3. Copy of Note file if issued by the office of the Tahsildar
4. Copies of any other documents relating to issuance of license etc.

The Public Information Officer has furnished the information to the appellant vide Lr.No.D/846/2022, dated 08-03-2022.

Since the appellant was not satisfied with the information received from the Public Information Officer, he filed 1st appeal dated **28-03-2022** before the 1st Appellate Authority U/s. 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority, vide Lr.No. B4/1054/2022, dated 07-04-2022, requested the Public Information Officer to furnish the information to the appellant directly.

Further, the First Appellate Authority, vide Notice No.C5/2199/2022, dated 07-07-2022, posted the First Appeal for hearing on 30-07-2022 at 3.00 pm.

The Public Information Officer vide Lr.No.D/3106/2022, dated 18-08-2022 furnished a reply to the appellant.

As the appellant was not satisfied with the replies received from the Public Information Officer and the advise of the 1st Appellate Authority, he preferred this 2nd appeal before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

Basing on the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 23-01-2023.

The case is called on 23-01-2023. The Appellant is present. The Public Information Officer/ Sri CH.Sathish, Naib Tahsildar is present. The First Appellate Authority is absent.

The Appellant submitted that he did not receive the sought information from the Public Information Officer.

The Public Information Officer submitted that the appellant has not mentioned any file number to enable him to trace out the file. He further submitted that vide letter No. D/846/2022 dated 08-03-2022 and vide letter No. D/3106/2022 dated 18-08-2022, replies were furnished to the appellant.

The Commission has perused the replies furnished by the Public Information Officer and does not accept the reply dated 18-08-2022 wherein the Public Information Officer has taken exemption U/s.8(1)(h) of the RTI Act, 2005.

The Commission directed the appellant to visit the office of the Public Information Officer with all the material papers available with him to enable the Public Information Officer to trace out the concerned file and there upon the Public Information Officer shall furnish the sought information to the appellant.

With the above direction, the appeal is closed.
