ORDER

Sri P.N. Kumar Mahendhra has filed a Complaint dated NIL which was received by this Commission on 17-10-2022 for not getting the information sought by him from the PIO / O/o. the Gram Panchayat Secretary, Dasarlapalli Vill, Uppunuthala Mandal, Nagarkurnool Dist-509385.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **13-12-2021** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points:

- ⇒ Palle Pragathi apportioned the budget including reimbursed on the way to, in addition to Invoice Bills, from 2020-2021.
- ⇒ Swargadhamam apportioned the budget in conjunction with funded Account bills, from 2020-2021.
- ⇒ Village allocated budget three years.
- ⇒ Amount accumulated from House tax, Water Tax, combined with pending tax just before have been collected from:2019-2021.
- ⇒ Telangana Aasara Pension scheme list endorsed accomplices in addition to compensated inventory for the year 2021.

In the information sent under RTI act section 2 (j)(ii), every copy must be attested. Under section6(2) An applicant requesting information shall not be required to give any reason for requesting the information or any other personal details except those that may be necessary for contacting him.

The Public Information Officer has not furnished the information to the Complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission U/s. 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

Basing on the material papers available on record, the complaint was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 21-02-2023.

The case is called on 21-02-2023. The Complainant is absent. The Public Information Officer is absent.

The Commission directs the Public Information Officer to furnish the sought information to the complainant, within two weeks from the date of receipt of this order and submit compliance report to the Commission.

With the above direction, the complaint is closed.
