ORDER

Smt. K. Beena (Alias Beena Bai) has filed 2nd appeal dated 13-10-2022 which was received by this Commission on 19-10-2022 for not getting the information sought by him from the PIO / O/o. the Tahsildar, Maddur Mandal, Siddipet Dist-502103 and 1st Appellate Authority / O/o. the Revenue Divisional Officer, Husnabad Division, Siddipet Dist-505467.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **02-07-2022** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points:

మహారాజశ్రీ గౌరవ అధికారి గారికి, పైన విషయమందు తమకు తెలియచేయుచున్న ప్రకారము, తెలుపబడిన సర్వే నెంబర్లకు తమ కార్యాలయము నుండి ఇవ్వబడిన మెమో నెం. ఎ/40/2021, తేదీ 17.12.2021 ద్వారా మాకు తెలుపుచున్న ప్రకారము మెమో నెం. ఎ/68/2021, తేదీ 26.03.2021, మెమో నెం. ఎ/28/2021 తేదీ 01.11.2021 ద్వారా ఇవ్వబడిన సమాచారము మేరకు మేము ది 16.03.2022 యందు పెట్టుకున్న రిక్వెస్ట్ అర్జీ ద్వారా తీసుకున్న పహానీ సకళ్ళయందు తెలుపుచున్న ప్రకారము "1994-1995" సం॥పు పహానీ రికార్డు యందున్న పట్టేదారులు మరియు అనుభవదారులు నిర్ధారించి రికార్డు యందు చేర్చుట గుర్తించబడిన 1994-1995 సం॥మునకు ముందు రికార్డుల వివరాలు మరియు రికార్డుల యందు చేర్చుటకు జరిపిన పూర్తి ప్రొసీడింగ్స్ పైలు వివరాలు ఇవ్వకోరుచు, కోరుచున్న పూర్తి రికార్డు వివరాలు ఇచ్చుటకు అయ్యే మొత్తము ఛార్జీలు చెల్లించుటకు సిద్ధముగా ఉన్నాము. కావున తమరు మాయందు దయవుంచి సత్వరమే సమాచారము ఇవ్వకోరుచున్నాను.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated **26-08-2022** before the 1st Appellate Authority U/s. 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

Basing on the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 14-02-2023.

The case is called on 14-02-2023. The Appellant is present. Sri B.Yadagiri, Senior Assistant is present on behalf of the Public Information Officer. The First Appellate Authority is absent.

The Appellant submitted that the Public Information Officer has furnished only pahanies to him and orally informed him that the records relating to the remaining information were burnt by naxalites.

The Public Information Officer submitted that copies of pahanies were furnished to the appellant and vide letter No. A/407/2022 dated 25-11-2022, a reply was furnished to the appellant informing him that since he has not furnished the file number, the sought information was not furnished to him and further asked the appellant to visit their office during working hours, inspect the available records and collect the required information, but the appellant did not turn up.

Heard both sides and perused the material papers available on record.

The Commission directed the Public Information Officer to furnish available and held information to the appellant and also furnish appropriate reply explaining the factual position with regard to the information which is not available in their office, within two weeks from the date of receipt of this order and submit compliance report to the Commission.

With the above direction, the appeal is closed.
