ORDER

Sri Y. Narahari has filed a Complaint dated 15-10-2022 which was received by this Commission on 19-10-2022 for not getting the information sought by him from the PIO / O/o. the District Registrar, Registration and Stamps, Sangareddy Dist-502285.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **02-07-2021** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points:

I enclose herewith copy of prohibited properties downloaded from your website, and also enclose herewith District collector's letter no. F1/2051/06 dated 28.01.2017. and it is evident that registration in sy.no.1018 is prohibited however registrations being carried out uninterruptedly since then.

In these circumstances under RTI act 2005 please provide me the reasons for registering the properties, though they are prohibited properties as per your website.

The Public Information Officer has furnished a reply to the Complainant vide Lr.No.RTI/262/2021, dated 27-07-2021.

As the Complainant was not satisfied with the reply received from the PIO, he preferred this Complaint before the Commission U/s. 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

Basing on the material papers available on record, the complaint was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 09-02-2023.

The case is called on 09-02-2023. The Complainant is present. The Public Information Officer/ Dr.S.Laxma Reddy, Joint Sub-Registrar-I is present.

The Public Information Officer submitted that a reply was furnished to the complainant vide letter No.RTI/262/2021 dated 27-07-2021 rejecting his request since he has raised a query through his RTI application.

The Complainant submitted that he has received the above reply from the Public Information Officer.

A perusal of the 6(1) application would show that the complainant has sought the reasons for registering prohibited properties. As per the RTI Act, the reasons cannot be sought by filing an application U/s. 6(1) of the RTI Act. In the instant case the sought information does not fall under the purview of the RTI Act.

The appeal is closed upholding the reply furnished by the Public Information Officer.
