## **ORDER**

Sri P. Kishore Kumar has filed three 2<sup>nd</sup> appeals dated NIL-10-2022 which were received by this Commission on 22-10-2022 for not getting the information sought by him from the Public Information Officer-1 / O/o. the Tahsildar, Sangareddy Mandal & District, Public Information Officer-2 / O/o. the Revenue Divisional Officer, Sangareddy Division & Dist and Public Information Officer-3/ The Dist. Revenue Officer, O/o. the Dist. Collector, Sangareddy District and 1<sup>st</sup> Appellate Authority-1 / O/o. the Revenue Divisional Officer, Sangareddy Division & District and 1<sup>st</sup> Appellate Authority-2 / The Dist. Revenue Officer, O/o. the Dist. Collector, Sangareddy Dist.

The brief facts of these cases as per the appeals and other records received along with them are that the appellant herein filed an application dated **11-05-2022** before the Public Information Officers under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points:

1. సంగారెడ్డి మండలం, కులబ్గూర్ గ్రామ ఫరిదిలో సర్వేనంబర్ 216/1 లో రాజ్యలక్ష్మి భర్త: వి.యస్.ఆర్. రాజు గారికి ఎటువంటి ప్రతిపాదనలతో 10 ఎకరాల 1 గుంట భూమిని వారికి ఇచ్చారు అట్టి పూర్తి రికార్డుల నకలు ఇవ్వగలరు.
2. సంగారెడ్డి మండలం, కులబ్గూర్ గ్రామ ఫరిదిలో సర్వేనంబర్ 216/3 లో సురేశ్ బాబు, తండ్రి: శ్రీధర్ స్వామి గారికి ఎటువంటి ప్రతిపాదనలతో 10 ఎకరాల 8 గుంటల భూమిని వారికి ఇచ్చారు అట్టి పూర్తి రికార్డుల నకలు ఇవ్వగలరు.

The Public Information Officers have not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officers, he filed 1<sup>st</sup> appeals dated **14-06-2022** before the 1<sup>st</sup> Appellate Authorities U/s. 19(1) of the RTI Act, 2005 requesting them to furnish the information sought by him.

The 1<sup>st</sup> Appellate Authorities failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeals filed before them.

As the appellant did not get the information from the Public Information Officers / 1<sup>st</sup> Appellate Authorities even after 30 days of filing his 1<sup>st</sup> appeals, he preferred these 2<sup>nd</sup> appeals before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the Public Information Officers and 1<sup>st</sup> Appellate Authorities for not furnishing information sought by him and also to arrange to furnish the information sought by him.

Basing on the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 17-02-2023.

The cases are called on 17-02-2023. The Appellant is absent. The Public Information Officer-1/ Md. Sadath, Naib Tahsildar O/o. the Tahsildar, Sangareddy Mandal, Sangareddy District is present. Sri V.Ranjith Nayak, Typist is present on behalf of the Public Information Officer-2 / O/o. the Revenue Divisional Officer, Sangareddy Division, Sangareddy District. Md. Sadath, Naib Tahsildar is present on behalf of the Public Information Officer-3/ O/o. the District Collector, Sangareddy District is absent. The First Appellate Authorities 1&2 are absent.

Since the appellant and the 6(1) application in all these cases are similar, these three cases are clubbed together and a common order is passed.

The Public Information Officer-2 submitted that the 6(1) application was transferred U/s. 6(3) of the RTI Act to the Public Information Officer-1.

The Public Information Officer-1 submitted that available information was furnished to the appellant vide letter No. B/RTI/5215/2022-2 dated 29-06-2022. He further submitted that in the year 2000-2001, the name of one Smt Rajyalakshmi was entered, but no proceedings are available in their office basing on which the said entry was made.

Since proof of service of the above said information dated 29-06-2022 is not produced before the Commission, the Commission directed the Public Information Officer to furnish the above said information once again to the appellant and further directed the Public Information Officer to furnish the factual position to the appellant with regard to the remaining information, within two weeks from the date of receipt of this order and submit compliance report to the Commission.

With the above direction, these appeals are closed.
