## **ORDER**

Sri E. Murali has filed 2<sup>nd</sup> appeal dated 22-10-2022 which was received by this Commission on 25-10-2022 for not getting the information sought by him from the PIO / O/o. the Dist. Rural Development Officer, Suryapet, Suryapet District and 1<sup>st</sup> Appellate Authority / O/o. the Dist. Rural Development Officer, Suryapet, Suryapet District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 18-08-2022 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points:

- 1) రైతులు పోషన ధాన్యం పేర్లు వీరియల్ నెంబర్ బుక్ వివరాలు
- 2) రైతుల దగ్గర కొన్ని ధాన్యం బస్తాలు క్వంటాల వివరాలు
- 3) రైతుల ధాన్యం ఏరోజు ఏ ట్రక్ షేట్ లో ఏ మిల్లుకు వెళ్లిన వివరాలు
- 4) రైతులు ధాన్యం ఏ రోజు ఏ లారీ నెంబరు బండి లో ఏ షిట్ కు వెళ్లిన వివరాలు
- 5) ICP కి మూడు సార్లు ఏ మిల్లులు కేటాయించిన వివరాలు
- 6) మూడు సార్లు గాను మిల్లుకు పంపిన బస్తాలు క్వంటాల ఫైనల్ రిపోర్ట్ వివరాలు
- 7) మూడు సార్లు గాను రైతుల పేముల్ అయినా రిపోర్ట్ వివరాలు
- 8) మూడు సార్లు గాను పంపించిన మిల్లులో రైతుల ధాన్యం షార్ట్ అని కట్ చేసిన క్వంటాల హ్యాండ్ బస్తాల వివరాలు

ఇవన్నీ స్థాయందు దయతలిచి ఏ కార్ కు ఆ కారు సవరణ సవరణ ఇవ్వగలరని మనవి.

The Public Information Officer / O/o. the Dist. Rural Development Officer, Suryapet, Suryapet District vide Lr.No. DRDA/C/101/2022, dated 25-08-2022 has transferred the RTI application U/s. 6(3) of the RTI Act to the Public Information Officer / O/o. the Asst. Project Manager, Mandal Samakhya, Thungathurty, Suryapet District to furnish the information directly to the Complainant under intimation to their office.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 19-09-2022 before the 1<sup>st</sup> Appellate Authority U/s. 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority vide Lr.No. DRDA/C/682/2022, dated 24-09-2022 instructed the Public Information Officer/APM, Mandal Samakhya, Thungathurthy Mandal, Suryapet District to furnish the complete information to the appellant.

As the appellant did not get the information from the Public Information Officer / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

Basing on the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 14-02-2023.

The case is called on 14-02-2023. The Appellant is present. The Public Information Officer /Sri P.Narsaiah, Assistant Project Manager is present at 1.00 pm. The First Appellate Authority is absent.

The Appellant submitted that he has received part information from the Public Information Officer.

The Public Information Officer submitted that available and held information consisting of 185 pages was furnished to the appellant vide letter No. C/290/RTI/2022 dated 21-10-2022(dispatched on 29-10-2022).

The Commission has perused the above information dated 21-10-2022 furnished by the Public Information Officer to the appellant.

Since available and held information was furnished, the appeal is closed.
