## ORDER

Sri Prashant Kumar Jha has filed 2<sup>nd</sup> appeal dated 20-10-2022 which was received by this Commission on 20-10-2022 for not getting the information sought by him from the PIO / O/o. the Tahsildar, Maheshwaram Mandal, Ranga Reddy Dist-501359 and 1<sup>st</sup> Appellate Authority / O/o. the Revenue Divisional Officer, Kandukur Division, Ranga Reddy Dist-501359.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 05-05-2022 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points:

1. Sethwar Register for all sub-divisions numbers under Survey No 70 for Mansanpally village from 1998 to 2021
  2. Register for issue of supplementary Sethawars for Mansanpally from 1998 to 2021
  3. Supplementary Sethwars issued for all Sub-division numbers under Survey No. 70 of Mansanpally village from 1998 to 2021
  4. Extract of Form-1B in respect of Jerpula Ghansya S/o Man Singh R/o Mansanally from 1989 onwards.
  5. Extract of Form-1B in respect of Jerpula Laxmi Alias Jerpula Laxamma W/o Jerpula Ghansya R/o Mansanally from 2006 onwards.
  6. Extract of Form-1B in respect of Jerpula Bichya S/o Jerpula Ghansya R/o Mansanally from 1987 onwards.
  7. Tippan Book for all sub-division numbers under Survey No.70 of Mansanpally village
  8. Wasool Baqi register for all sub-division numbers under Survey No.70 of Mansanpally village.
  9. Touch Plot for all sub-division under Survey No. 70 of Mansanpally village
  10. Copy of Form VI(A) – "Intimation by any person regarding acquisition of Rights" received from Sri N.Sridhar Venkat Rao, Sri. A. Yadagiri Rao and five others in respect of Sale deed Regd. Document No. 14239/2006 Dt.2.9.2006 ( Under Rule 18 and Sec 4(1) of the RoR Act1971 ).
  11. Copy of Form-VI B- received from SRO, Maheshwaram in respect of Sale deed Regd. Document No. 14239/2006 Dt.2.9.2006 (under Rule 18 of RoR Rules 1989 and RoR Act1971)
  12. Form-VII- "Register of Amendments" for Mansanpally Village for the year 2006, 2007,2008,2019,2020 and 2021 (under Rule 18(3) of RoR Rules 1989, RoR Act1971)
  13. Form XVI- "Register showing particulars of registered documents or intimations received in MRO, Maheshwaram office from Sub\_Registrar, Maheshwaram" under Rule 18(3), 27(2) of A.P. Rights in land and Pattadar Passbook Rules 1989 for the year 2006,2008,2019,2020 and 2021.
  14. Form XVIII- under Rule 26(5) of RoR Rules1989 – "Register of Title deeds/Passbooks issued and Khata number assigned for the Mansanpally Village for the year 2006,2007,2008,2009,2019,2020.
  15. Village Account No 11- "Register of Deaths" for Mansanpally village for the period 1987 to 2009.
  16. Village Map for Mansanpally.
  17. Entire file dealing with Mutation/succession Proceeding No. D/602/2008 Dt. 18.12.2006 of Tehsildar, Maeshwaram for Ac.2.00 falling in Sy.No. 70 of Mansanpally Village in favour of Smt Jarpuia Laxamma W/o late Jarpuia Ghansia from Late Jarpuia Bichia S/o Jarpuia Ghansya.( Grant of Succession ) issued under RoR Act 1971
  18. Entire file dealing with Mutation Proceeding No. D/33/2006 Dt. 18.2.2008 of Tehsildar, Maeshwaram for Ac.1-30 Gt falling in Sy.No. 70 of Mansanpally Village in favour of Sri. A. Yadagiri Rao, Sri N.Sridhar Venkat Rao, and five others in respect of Sale deed Regd. Document No. 14239/2006 Dt.2.9.2006 sold by Jarpuia Ghansya ( Acquisition of rights by purchase through regd.deed- mutation granted under Sec 4 and 5 of RoR Act 1971)
  19. Certified copy of record of rights entered in Form-1B Register along with entire note and current file related Pattai/Khata No. 1074 to 1080 in 2006 of Masanpally Village, Maheshwaram Mandal
- After inspection of the above records/documents made available, the required certified extract of the documents as marked by me may also be supplied under provisions of the RTI Act 2005.
5. Period to which the information relates:- From 1998 to 2020.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 13-06-2022 before the 1<sup>st</sup> Appellate Authority U/s. 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has furnished reply to the appellant vide Lr.No. D/RTI/1740/2022, dated 15-09-2022.

As the appellant did not get the information from the Public Information Officer and he was not satisfied with the reply received from the 1<sup>st</sup> Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

Basing on the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 17-02-2023.

The case is called on 17-02-2023. The Appellant is absent. Smt D.Balamani, Junior Assistant is present on behalf of the Public Information Officer. The First Appellate Authority is absent.

The representative of the Public Information Officer submitted that the appellant has visited their office and collected the available information.

Since proof of service is not produced before the Commission, the Commission directed the Public Information Officer furnish the sought information once again to the appellant forthwith and submit compliance report to the Commission.

With the above direction, the appeal is closed.
