ORDER

Dr. Hamid Hussain Shariff has filed 2nd appeal dated 26-10-2022 which was received by this Commission on 27-10-2022 for not getting the information sought by him from the PIO / O/o. the Asst. Director, Survey and Land Records, Sangareddy Dist-502001 and 1st Appellate Authority / O/o. the Asst. Director, Survey and Land Records, Sangareddy Dist-502001.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 12-05-2022 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points:

Undersigned hereby bring to your notice that Ashoorkhana Majid & Graveyard land bearing Survey No. 27 in Amdoor Village under Jinnaram Tahsil has been illegally sub divided in 27/1, 27/2 & 27/3 by land grabbers. Dharani record shows subdivision of 27/3 admeasuring 16 guntas is registered to Mr Pichacotlord Chinniah S/O Yeliah which is illegal and furthermore is a violation of monuments Act & violation of place of worships Act. Khasra Pahani dated 2012 Issued by Tahsil also shows total land acre 1.25 guntas. We already informed to your office on three occasions on 02/10/2022, 03/06/2022 & 09/05/2022 via email to adsirsrd@gmail.com about illegal construction being carried out by Mr. Pichacotlord Durgesh & Mr Satyanarayana. This Ashoorkhana, Masjid & Grave Yard is currently under petition to Hon'ble High Court of Telangana (Case ID: WP6688/2022) for protection and preservation under Telangana Heritage Department, Gunfoundary, Abids, Hyderabad 500001

Further to the above information I am seeking the below required information in an attested manner Under RTIA Act -2005, as per Section 2, 4(1), 6(1), 6(2) & 6(3) within prescribed time limit preferably at the earliest possible.

1. Attested copy(s), Total Connected Records in your office that are linked and associated with Survey No. 27 admeasuring acre 1.25 guntas in Amdoor Village, Jinnaram Tahsil, Sangareddy District.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 07-07-2022 before the 1st Appellate Authority U/s. 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The Public Information Officer has furnished a reply to the appellant vide RC.No.A10/881/2022, dated 24-08-2022.

The 1st Appellate Authority failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant was not satisfied with the reply received from the Public Information Officer and did not receive any response from the 1st Appellate Authority, he preferred this 2nd appeal before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

Basing on the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 17-02-2023.

The case is called on 17-02-2023. The Appellant is present. The Public Information Officer / Sri Inesh, Assistant Director is present. The First Appellate Authority is absent.

The Public Information Officer submitted that vide Memo Rc.No.A10/881/2022 dated 24-08-2022, a reply was furnished to the appellant stating that the Wasoolbaqui of the sought survey number is in torn condition. He further submitted that the appellant has visited their office, inspected the files and took photos of the required information.

The Appellant has admitted that he has visited the office of the Public Information Officer and took photos of the required information.

In view of the above, the appeal is closed.
