ORDER

Sri Eldasari Jyothi @ Geedi Jyothi has filed 2nd appeal dated 28-10-2022 which was received by this Commission on 29-10-2022 for not getting the information sought by him from the PIO / O/o. the Dist. Collector, Kongar Kalan, Ibrahimpattam, Ranga Reddy Dist and 1st Appellate Authority / O/o. the Dist. Collector, Kongar Kalan, Ibrahimpattam, Ranga Reddy Dist.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 11-08-2022 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points:

- 1) Please provide me the complete **CERTIFIED / ATTESTED** copies of Action Taken Report in respect of my Complaint, Dt: 27-11-2021 submitted before Collector & District Magistrate, Ranga Reddy District. A copy of complaint is enclosed for kind perusal.
- 2) Please provide me the complete **CERTIFIED / ATTESTED** copies of Report (if any) received from Revenue Divisional Officer, Ibrahimpattam Division in respect of instructions from Collector & District Magistrate, Ranga Reddy District vide Lr. No. A3/28/2021, Dt: 09-02-2022, and if no report is received from concerned public authority, then kindly inform the administrative action initiated by Collector & District Magistrate, Ranga Reddy District for receiving the detailed report (Please refer Section 4 (1) (d) of RTI Act, 2005) A copy of said instructions copy is enclosed for kind perusal.
- 3) Please provide me the complete **CERTIFIED / ATTESTED** copies of Action Taken Report in respect of Tweet sent to Official Twitter handle of Collector & District Magistrate, Ranga Reddy District, i.e. www.twitter.com/CollectorRRD from my Twitter ID www.twitter.com/jyothi_anindian on Dt: 10-08-2022 and on Dt: 11-08-2022. A copy of Twitter screenshot is enclosed for kind perusal.
- 4) Please provide me the complete **CERTIFIED / ATTESTED** copies of Action Taken Report in respect of my Email, Dt: 10-08-2022 sent from my Email ID: eldasari.jyothirmayee@gmail.com to Email IDs: collectorpeshirrd@gmail.com, dropseshi@gmail.com, ic_rr@telangana.gov.in & aorangareddydistrict@gmail.com. A copy of email is enclosed for kind perusal.
- 5) Please provide me the complete **CERTIFIED / ATTESTED** copies of permission granted by concerned authorities permitting the concerned people Domalapally Santhosha and Mr. Jangaiah to construct any structure on Plot No: 26 and Plot No: 27 of Survey No: 38 located at Weaker Section Colony, Munganoor Village, Abdullapurmet Mandal. If the information is not available with O/o Collector & District Magistrate, Ranga Reddy District, then kindly inform that No information available or No permission is granted and kindly do not transfer the RTI Application to Abdullapurmet Mandal.
- 6) Please provide me the complete **CERTIFIED / ATTESTED** copies of permission granted by concerned authorities permitting the concerned person Mr. Jangaiah to dig the bore in Plot No: 27 of Survey No: 38 located at Weaker Section Colony, Munganoor Village, Abdullapurmet Mandal. If the information is not available with O/o Collector & District Magistrate, Ranga Reddy District, then kindly inform that No information available or No permission is granted and kindly do not transfer the RTI Application to Abdullapurmet Mandal.
- 7) Please provide me the complete **CERTIFIED / ATTESTED** copies of roles and responsibilities of Tahsildar pertaining to safeguarding the lands belonging to government.
- 8) Please provide me the complete **CERTIFIED / ATTESTED** details regarding who is the custodian of Plot No: 26 of Survey No: 38 located at Weaker Section Colony, Munganoor Village, Abdullapurmet Mandal, i.e. whether this department is the custodian or any other person is the custodian, if so then kindly provide the complete details of the custodian.
- 9) Please provide me the complete **CERTIFIED / ATTESTED** copies of all the correspondence documents made by O/o Collector & District Magistrate, Ranga Reddy District with Hon'ble Telangana State Human Rights Commission in H.R. Case No: 6452/2021.
- 10) Please provide me the complete **CERTIFIED / ATTESTED** details of time taken by Collector & District Magistrate, Ranga Reddy District to respond / reply to the tweets sent by various people received on the Official Twitter handle of Collector & District Magistrate, Ranga Reddy District, i.e. www.twitter.com/CollectorRRD.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 16-09-2022 before the 1st Appellate Authority U/s. 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

Basing on the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 15-02-2023.

The case is called on 15-02-2023. The Appellant is absent. Smt K.Pramila Rani, Administrative Officer is present on behalf of the Public Information Officer. The First Appellate Authority is absent.

The representative of the Public Information Officer submitted that she has brought the sought information vide Memo No.A5/RTI/3762/2022 dated 14-02-2023, to furnish to the complainant.

Since the complainant is absent, the Commission directed the Public Information Officer to furnish the above said information dated 14-02-2023 to the complainant forthwith through RPAD and report compliance to the Commission.

With the above direction, the complaint is closed.
