ORDER

Sri J. Sai Kumar has filed a Complaint dated 05-02-2021 which was received by this Commission on 08-02-2021 for not getting the information sought by him from the PIO / O/o. the Dist. Registrar, Ranga Reddy Dist., Prashanth Nagar, Kukatpally, Hyderabad-500072.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **08-12-2020** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

In this connection please arrange to provide the following information/documents.

1. Copies of the Proceedings, note sheets and other documents of the File/proceedings etc in which the above Letter (2) is/was processed/dealt.
2. Copies of all the instructions/guidelines/Orders/ notes etc issued in the case.
3. Copies of the Proceedings/reports of Investigation/enquiry etc related to the case.
4. Copies of the correspondence made between % District Registrar RR and field units like Sub Registrars and other officers and offices etc.
5. Copies of the Reports received from the above (item 4) offices/officers.
6. Copies of correspondence made between % District Registrar RR and DIG (R&S) RR.
7. Copy of the Report submitted to the Commissioner(R&S)TS.
8. Copies of the Instructions/directions etc issued to the field units, in this regard.
9. Copies of Audit/Internal check reports on such Plot registrations where Land/plot under Peri-urban zone were registered as Normal zone etc.

The Public Information Officer has furnished a reply to the Complainant vide Lr.No.479/Societies/RTI/2020, dated 21-01-2021.

As the Complainant was not satisfied with the reply received from the PIO, he preferred this Complaint before the Commission U/s. 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

Basing on the material papers available on record, the complaint was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 02-01-2023.

The case is called on 02-01-2023. The Complainant is absent. Sri J.Srikanth Reddy, Joint Sub-Registrar-II is present on behalf of the Public Information Officer.
