ORDER

Sri M. Padmakar Rao has filed a Complaint dated 01-12-2022 which was received by this Commission on 03-12-2022 for not getting the information sought by him from the PIO / O/o. the Tahsildar, Ibrahimpatnam Mandal, Ranga Reddy Dist.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **07-06-2019** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

I, Maramraju Padmakar Rao, s/o M. Rama Rao of Raipole village request you to provide me the following information at the earliest under **Right to Information Act of 2005**. Please provide me the certified Xerox copy of the extracts of the register listing out the names of the pattedars along with their khata nos and the survey numbers to whom the new pattedar pass books were issued and the cheques were handed over under Rytubandhu for the lands in of the Raipole village, Ibrahimpatnam mandal.

The Public Information Officer has not furnished the information to the Complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission U/s. 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

Basing on the material papers available on record, the complaint was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 23-01-2023.

The case is called on 23-01-2023. The Complainant is absent. The Public Information Officer/ Sri K.Srinivas, Naib Tahsildar is present.

The Public Information Officer submitted that vide letter No.RTI/09/2019 dated 06-08-2019, information was furnished to the complainant.

The Commission has perused the information dated 06-08-2019.

Since information was furnished, the complaint is closed.
