ORDER

Sri M. Padmakar Rao has filed a Complaint dated 01-12-2022 which was received by this Commission on 03-12-2022 for not getting the information sought by him from the PIO / O/o. the Dist. Collector, Kongara Kalan, Ibrahimpatnam, Ranga Reddy Dist.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **17-07-2021** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

1. My surname, 'Maramraju' in my name and my father's surname was not mentioned in the new Pattdar Pass Book. In Telugu my name should have been 'పదకొక్క రంజీ' instead of 'పదకొక్క రాజు'. In fact this mistake was brought to the notice of the Tahsildar, Ibrahimpatnam, but he did not take any action till today. Copy of my Aadhar card is attached herewith as proof.
2. The lands in sy nos 20/EE (Ac0-11Gts), 44/EE (Ac0-19Gts), 48/EE (Ac0-19Gts), 106/EE(Ac0-13Gts), 107/EE(Ac0-03Gts) and other sy nos in Raipole village were inherited as part of my ancestral property. These lands and sy nos were mentioned in 1B register and some were recorded in the new Pattedar Pass Book also as part of Rytu Bandhu issued on 21/04/2018.
3. But these sy nos were missing in Dharani records in Pahani and the digital signatures were not done giving the reason that some 'civil court cases are pending'. But as a matter of fact the other sub sy nos in 20,44,48,106 and 107 the pass books were issued after the digital signature for others. I am herewith enclosing copies of Dharani records for sy nos 44/E, 44/EE, 48/A, 48/EE for your ready reference.
4. In fact there were no court cases are pending in any court of law for the lands mentioned survey nos and these survey nos are not figuring in the Prohibited Properties list also, a the copy of which is attached herewith.
5. I have approached the Tahsildar, Ibrahimpatnam and requested him several times to make corrections in the Dharani and other related records and incorporate these corrections in the new pattedar pass book. At the same time he had not given any reasons for issuing the pass books in the other sub sy nos for others.
6. The Thasildar is not responding to my petitions for making these corrections and he has not given any details of the so called pending civil court cases if at all they were pending in any court of law. I am herewith enclosing a copy of my Pattedar Passbook and the petition submitted to Tahsildar.

Hence I request you sir to look into these issues and the records in Dharani and my Pattedar passbook may be corrected and issue a new pass book after these corrections were made.

The Public Information Officer has not furnished the information to the Complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission U/s. 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

Basing on the material papers available on record, the complaint was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 23-01-2023.

The case is called on 23-01-2023. The Complainant is absent. Smt K.Pramila Rani, Administrative Officer is present on behalf of the Public Information Officer.

The representative of the Public Information Officer submitted that the complainant in his RTI application has sought for certain corrections in the pattadar passbook, in fact the complainant has to apply separately for such corrections. She further submitted that the RTI application was transferred U/s. 6(3) of the RTI Act to the Public Information Officer/O/o. the Tahsildar, Ibrahimpatnam Mandal, RR District vide letter No.A5/RTI/23696/2021 dated 25-10-2021.

The Commission has perused the RTI application filed by the complainant and directed the Public Information Officer to furnish appropriate reply to the complainant explaining the method to seek the corrections in the passbook. The Commission further directed the Public Information Officer to give a detailed reply to the complainant with regard to the pending Civil Court cases as sought by the complainant.

With the above direction, the complaint is closed.
