## **ORDER**

Sri M. Padmakar Rao has filed a Complaint dated 01-12-2022 which was received by this Commission on 03-12-2022 for not getting the information sought by him from the PIO / O/o. the District Collector, Kongara Kalan, Ibrahimpatnam, Ranga Reddy Dist.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **05-02-2020** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

I, Maramraju Padmakar Rao, s/o M. Rama Rao of Raipole village am the Pattedar, Occupier and enjoyer of the ancestral land property in survey nos 59,60,62,67,68,69,92 and other sy nos of Raipole village, Ibrahimpatan Mandal.

I have filed petitions to you highlighting my grievances against the Tahsildar, Ibrahimpatnam with reference nos a) RRDDC/E/2018/00219 dated 05-02-2018 and b) RRDDC/E/2019/00852 dated 30-09-2019. I request you to provide me the certified copies of the following documents in connection with the above mentioned petitions under the **Right To Information Act 2005**.

1. Certified copies of the action taken report.
2. Certified copies of all the correspondence with the Tahsildar, Ibrahimpatnam in connection with my above mentioned petitions to you.

The Public Information Officer has not furnished the information to the Complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission U/s. 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

Basing on the material papers available on record, the complaint was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 23-01-2023.

The case is called on 23-01-2023. The Complainant is absent. Smt K.Pramila Rani, Administrative Officer is present on behalf of the Public Information Officer.

The representative of the Public Information Officer submitted that the RTI application was transferred U/s. 6(3) of the RTI Act to the Public Information Officer/O/o. the Tahsildar, Ibrahimpatnam Mandal, RR District vide letter No.A5/RTI/3525/2020 dated 10-03-2020.

The Commission directed the Public Information Officer/O/o. the Tahsildar, Ibrahimpatnam Mandal, RR District to furnish the sought information to the complainant, two weeks from the date of receipt of this order and submit compliance report to the Commission.

With the above direction, the complaint is closed.
