ORDER

Sri Ramachary has filed a Complaint dated 12-12-2022 which was received by this Commission on 16-12-2022 for not getting the information sought by him from the PIO / O/o. the Dy. Commissioner, Greater Hyderabad Municipal Corporation, Circle No. 3, Hayathnagar Circle, Saroornagar, Hyderabad-500035.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **22-10-2022** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

1. నేను తేది. 16-09-2022 నాడు మీ యొక్క అఫీస్ కి ఒక వినతి పత్రము పంపించాను. అట్టి వినతి పత్రము పై మీరు ఏమి చర్యలు తీసుకున్నారో సమాచారం పంపగలరు.
2. నా వినతి పత్రము పై చర్యలు తీసుకోకపోతే, అందుకు గల కారణములు తెలుపగలరు.
3. ప్రజా సమస్యల పై వినతి పత్రము మీ అఫీస్ కి వచ్చినప్పుడు దాన్ని ఎన్ని రోజులలో పరిష్కరిస్తారు! తెలుపగలరు.
4. నా యొక్క వినతిపత్రము తేది. 16-09-2022 పై తీసుకున్న రోజువారీ చర్యల ప్రతులు పంపించండి.
5. మీ అఫీసు యొక్క సెక్షన్ 4(1)(b) సమాచారం పంపగలరు.

The Public Information Officer has not furnished the information to the Complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission U/s. 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

Basing on the material papers available on record, the complaint was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 12-01-2023.

The case is called on 12-01-2023. The Complainant is absent. Dr.D.Yadagiri, Veterinary Officer is present on behalf of the Public Information Officer.

The Public Information Officer submitted that information was furnished to the complainant on 20-12-2022 under proper acknowledgment.

The Commission has perused the information furnished by the Public Information Officer to the complainant on 20-12-2022.

Since information was furnished, the complaint is closed.
