ORDER

Sri J. Ramesh has filed 2nd appeal dated 12-04-2021 which was received by this Commission on 12-04-2021 for not getting the information sought by him from the PIO / O/o. the Tahsildar, Serilingampally Mandal, Ranga Reddy Dist-500014 and 1st Appellate Authority / O/o. the Revenue Divisional Officer, Rajendranagar Division, Ranga Reddy Dist-500030.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 16-10-2020 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 30-12-2020 before the 1st Appellate Authority U/s. 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has issued notice to the appellant and the Public Information Officer / The Naib Tahsildar, Serilingampally Mandal, Ranga Reddy Dist vide Lr.No.RTI-Appeal/79/2020, dated 18-01-2021 to appear before his office for hearing on 27-01-2020 at 3:00 PM along with relevant records.

As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

Basing on the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 03-01-2023.

The case is called on 03-01-2023. The Appellant is present. The Public Information Officer/ Sri G.Shanker, Naib Tahsildar is present. The First Appellate Authority is absent.

The Appellant submitted that he did not receive the sought information from the Public Information Officer.

The Public Information Officer submitted that since the appellant is seeking information relating to the rivers in the entire mandal along with the extent and the particulars relating to the extent are not available with their office, he has addressed a letter to the Irrigation department as the same would be available with them.

The Commission directed the Public Information Officer to furnish the available and held information to the appellant, within two weeks from the date of receipt of this order and submit compliance report to the Commission.

With the above direction, the appeal is closed.
