## **ORDER**

**Sri Mohammad Ghaziuddin, R/o Hyderabad** filed 2<sup>nd</sup> appeal dated 00-10-2020 which was received by this Commission on 27-11-2020 for not getting the information sought by him from the PIO / Director of Agriculture Marketing, O/o The Director of Agriculture Marketing,H.No.3-6-184, 2<sup>nd</sup> Floor, Telangana State Housing Corporation Limited, Urdu Hall Galli, Himayathnagar, Hyderabad and 1<sup>st</sup> Appellate Authority / Director of Agriculture Marketing, O/o The Director of Agriculture Marketing,H.No.3-6-184, 2<sup>nd</sup> Floor, Telangana State Housing Corporation Limited, Urdu Hall Galli, Himayathnagar, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 20-07-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

1. What is the sanctioned cadre strength of Deputy Director of Marketing in Agricultural Marketing Department? Furnish all GO copies of sanctioned posts of DDM.
2. How many Dy. Director of Marketing presently working in Telangana. Where they are working, from where they are drawing Pay & Allowances? Candidate wise details to be furnish.
3. Furnish the order copies of all DDM who are working on OD basis.
4. How many Dy. Director of Marketing posts in O/o Director of Agril. Marketing, Hyderabad and how many are working?
5. What are the present Pay Scale of Selection Gr. Secretary, Special Gr. Secretary and Dy. Director of Marketing?
6. Can Dy. Director of Marketing draw the pay and allowances against the Special Grade Secretary post Scale in AMC? If Yes, How and if No, Why?
7. Furnish the copy of note file in which (38) number of Asst. Director of Marketing cadre employees proposed for promotion to the post of Dy. Director of Marketing to the Government vide Lr. No. Estt. Govt. 1808/2010, Dated,20.11.2013.
8. What was the balance of CMF Budget Account maintain in O/o Director of Agril. Marketing, Hyderabad on 3.6.2014.
9. How much expenditure incurred from CMF budget on pay and allowances of employees working in O/o Director of Agril. Marketing, Hyderabad since 3.6.2014 to till date. Year wise and Employee wise information to be furnish.
10. What is the Standard Staffing Pattern (SSP) has proposed to the Government at the time of creation of new districts as directed while communicating the minutes of the meeting convened by the Chief Secretary to Govt. from 1.9.2016 to 3.9.2016. Provide copy of proposals.

The Public Information Officer through Letter No. 3925/Mktg-I(2)/2020 dated 26-08-2020 transferred the application U/s 6(3) to the Public Information Officer, Director of Agriculture Marketing, O/o The Director of Agriculture Marketing,H.No.3-6-184, 2<sup>nd</sup> Floor, Telangana State Housing Corporation Limited, Urdu Hall Galli, Himayathnagar, Hyderabad for furnishing the sought information.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 10-09-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **23-06-2022**.

On **23-06-2022** the case is called. The Appellant is absent. The Public Information Officer / Assistant Director, O/o the Director of Agriculture Marketing, Hyderabad is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the sought information running into (40) pages were furnished to the appellant on 21-6-2022 by RPAD.

The record goes to show that the 6(1) application was filed on 20-7-2020 and the Public Information Officer has furnished information to the appellant on 21-6-2022 with a delay of two years.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since exhaustive information is furnished, **the Appeal is closed.**

The Public Information Officer is **cautioned** to be prompt while dealing with application filed under RTI Act, 2005 and strictly adhere to the stipulated time limits with reference to Sec.7(1) of the RTI Act, 2005.
