ORDER

Sri MOHAMMED ARIF, R/o Jagityal District filed 2nd appeal dated 24-11-2020 which was received by this Commission on 27-11-2020 for not getting the information sought by him from the PIO / O/o The Telangana State Waqf Board, Razzak Manzil opp Public Garden, Nampally, Hyderabad and 1st Appellate Authority / O/o The Telangana State Waqf Board, Razzak Manzil opp Public Garden, Nampally, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **31-07-2020** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

1. How many Imam and Mouzzans are there in KORUTLA Town & Mandal in Jagtial District? Please provide details.
2. How many Imam and Mouzzans are given Honorarium in KORUTLA Town & Mandal in Jagtial District Please provide details
3. How many Imam and Mouzzans Honorarium was kept pending in KORUTLA Town & Mandal in Jagtial District Please provide details
4. Who is the official Qazi in KORUTLA Town in Jagtial District? I request you to give the Government appointment order of KORUTLA Qazi District Jagtial
5. What is the salary given to the KORUTLA Qazi and what are the facilities provided to the KORUTLA Qazi please provide the details
6. What is the fee for performing the marriage please provide the details

The Public Information Officer through letter No. 33/Qzt/RTIA/2020 dated 16-09-2020 furnished reply to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1st appeal dated **10-09-2020** before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **19-04-2022**.

On 19-04-2022 the case is called. The Appellant is absent. The Public Information Officer, O/o the CEO, T.S.Waqf Board, Nampally, Hyderabad is absent. The 1st Appellate Authority is absent.

The Public Information Officer filed a letter dated 18-4-2022 submitting that the staff of the entire Wakq Board are busy in duties for distribution of Gift packets to the Muslim community as ordered by the Government on the eve of Ramzan. Hence the Public Information Officer requested to adjourn the case after Ramzan.

In view of the above, the **Appeal was adjourned to 18-05-2022.**

On 18-05-2022 the case is called. The Appellant is present. The Public Information Officer, O/o the Telangana State Wakq Board, Haj House, Nampally, Hyderabad is present. The 1st Appellate Authority is absent.

The Appellant submitted that he did not receive the sought information from the Public Information Officer.

The Public Information Officer submitted that the appellant was informed on 16-10-2020 that the Korutla Town in Jagityala District comes under Qazzath Sarkar Yelagandala and as such requested the appellant to approach the concerned Qazzath.

The appellant is advised to approach the concerned Qazzath and obtain the sought information. The Commission directs the Public Information Officer to coordinate the matter with the Qazzath Sarkar Yalagandala and ensure that the sought information is furnished to the appellant within (15) days from the date of receipt of this order and report compliance to the Commission.

With the above direction, **the Appeal is closed.**
