ORDER

Sri Mohammad Ghaziuddin, R/o Hyderabad filed 2nd appeal dated 00-10-2020 which was received by this Commission on 27-11-2020 for not getting the information sought by him from the PIO / Director of Agriculture Marketing, O/o The Director of Agriculture Marketing,H.No.3-6-184, 2nd Floor, Telangana State Housing Corporation Limited, Urdu Hall Galli, Himayathnagar, Hyderabad and 1st Appellate Authority / Director of Agriculture Marketing, O/o The Director of Agriculture Marketing,H.No.3-6-184, 2nd Floor, Telangana State Housing Corporation Limited, Urdu Hall Galli, Himayathnagar, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 20-07-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

(1) of Right to Information Act within stipulated time.

- 1. What is the sanctioned cadre strength of Secretaries (Assistant Secretary to Selection Grade Secretary in AMC Services) in Agricultural Marketing Department?**
- 2. Who is the competent authority to sanction a Secretary Cadre post of AMC Services in Agricultural Marketing Department? Please furnish reference.**
- 3. Furnish all the sanction order copies of Secretary Posts (from Asst. Secretary to Selection Grade Secretary cadre).**
- 4. Howmany AMCs on 1-4-2003 in Telangana Region? Please furnish names with Grade.**
- 5. Howmany newly AMCs created after 1.4.2003? names and their Grade initially fixed.**
- 6. Howmany times AMCs Upgraded or Degraded since 1.4.2003? please provide all the order copies.**

The Public Information Officer through Letter No. 3925/Mktg-I(2)/2020 dated 26-08-2020 transferred the application U/s 6(3) to the Public Information Officer, Director of Agriculture Marketing, O/o The Director of Agriculture Marketing,H.No.3-6-184, 2nd Floor, Telangana State Housing Corporation Limited, Urdu Hall Galli, Himayathnagar, Hyderabad for furnishing the sought information.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 10-09-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **23-06-2022**.

On 23-06-2022 the case is called. The Appellant is absent. The Public Information Officer / Assistant Director, O/o the Director of Agriculture Marketing, Hyderabad is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that part information was furnished to the appellant on 10-5-2021 and complete information on 22-6-2022 by RPAD.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since exhaustive information is furnished, **the Appeal is closed.**
