## **ORDER**

Sri V. Srinivasa Chary, R/o Karimnagar District filed 2<sup>nd</sup> appeal dated 03-10-2020 which was received by this Commission on 03-10-2020 for not getting the information sought by him from the PIO / O/o The Commissioner, Karimnagar Municipal Corporation, Karimnagar District and 1<sup>st</sup> Appellate Authority / O/o The Commissioner, Karimnagar Municipal Corporation, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 11-09-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

The Public Information Officer through letter No. G2/Appeal No.012521/2020 dated 02-09-2020 furnished the sought information to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1<sup>st</sup> appeal dated 12-10-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **09-05-2022**.

On **09-05-2022** the case is called. The Appellant is absent. The Public Information Officer, O/o the Municipal Commissioner, Karimnagar Municipal Corporation, Karimnagar is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the sought information was furnished to the appellant on 05-10-2020 vide letter No.G2/391/RTI/2020.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since information is furnished, **the Appeal is closed.**
