ORDER

Sri V. Srinivasa Chary, R/o Karimnagar District filed 2nd appeal dated 03-12-2020 which was received by this Commission on 03-12-2020 for not getting the information sought by him from the PIO / O/o The Commissioner, Karimnagar Municipal Corporation, Karimnagar District and 1st Appellate Authority / O/o The Commissioner, Karimnagar Municipal Corporation, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 15-09-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

From submitted before you that the Honble District collector order vide Lr no H/2138/2019 dt 30/06/2020 and vide Lr no G2/2020 dt 30/06/2020 of the commissioner, Municipal Corporation and vide notice ROC NO TPO/5969/2019 dt 8/5/2019 of Municipal Corporation and vide FIR NO 28 dt 06/02/2020 of the L-MD colony police station for your kind perusal and requested you take necessary action and demolish illegal construction of the Komati Reddy Rajubari in my patta land sy no 501 situated at Aljunoor on date 10/07/2020.

please supply action taken report with certified as per my petition dt 10/07/2020

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 15-10-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **09-05-2022**.

On 09-05-2022 the case is called. The Appellant is absent. The Public Information Officer, O/o the Municipal Commissioner, Karimnagar Municipal Corporation, Karimnagar is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the sought information was furnished to the appellant on 15-10-2020

Heard the Public Information Officer and perused the records.

The appellant in his 6(1) application sought action taken report on his Complaint dated 08-5-2019 for removal of illegal constructions by Sri Komatireddy Rajaia, whereas the Public Information Officer informed that no permission is granted to the above person for constructions of house. Thus, the Public Information Officer has furnished irrelevant information.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

The Commission directs the Public Information Officer to furnish action taken report on his Complaint dated 08-05-2019 for removal of illegal constructions by Sri Komatireddy Rajaiah to the appellant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**
