ORDER

Sri NUTAN BABU JANNU, R/o Warangal Urban District has filed a Complaint dated 28-11-2020 which was received by this Commission on 03-12-2020 for not getting the information sought by him from the PIO / O/o The Collector, Warangal Urban District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 06-01-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on 23-05-2022.

On 23-05-2022 the case is called. The Complainant is absent. The Public Information Officer, O/o the District Collector, Warangal Urban is absent.

The record goes to show that the 6(1) application was filed on 6-1-2020 and the Public Information Officer has not furnished sought information to the Complainant so far.

The Commission directs the Public Information Officer to furnish sought information to the Complainant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Complaint is closed.**

Issue **show cause notice** to Public Information Officer for not furnishing the sought information to the Complainant within the stipulated time and for not attending hearing before the Commission. The action on the show cause notice shall be dealt with separately.
