## **ORDER**

Sri S. KISHAN, R/o Karimnagar District has filed a Complaint dated 24-11-2020 which was received by this Commission on 05-12-2020 for not getting the information sought by him from the PIO / O/o The Municipal Commissioner, Kothapalli Municipality, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 29-09-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

Sir,

In reference to the above subject I Sana Kishan s/o Narsaiah being the original pattadar of sy.no. 80 situated at kothapalli(H) village one mandala Srinivas Reddy s/o Narayan Reddy R/O of Karimnagar has acquired construction permission from the GP kothapalli(H) in the year 2018 in sy.no. 80 showing my land with a fabricated document therefore the documents and the link documents submitted by the said mandala Srinivas Reddy to acquire permission. Did he mention any case pending in the court and the enquiry report made by the officials before granting the permission and permission copy are required to me

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on 15-06-2022.

On 15-06-2022 the case is called. The Complainant is absent. The Public Information Officer / Municipal Commissioner, Kothapalli Municipality, Karimnagar District is present.

The Public Information Officer submitted that the sought information is ready and will be sent to the Complainant immediately.

The Commission observed that the 6(1) application was filed on 29-5-2020 and the information is being sent today.

The Commission took a serious view in the delay of furnishing information and directs the Public Information Officer to be more careful in future while dealing with the applications filed under RTI Act, 2005.

The Commission directs the Public Information Officer to furnish sought information to the Complainant by RPAD immediately and submit compliance to the Commission.

With the above direction, **the Complaint is closed.**

Issue **show cause notice** to the then Public Information Officer for not furnishing the sought information to the appellant within the stipulated time. The action on the show cause notice shall be dealt with separately.
