ORDER

1. **Sri D.N.SADANAND**, #6-4-114, Sai Baba Nagar, Kattadan, Rajendranagar, R.R.District-500077 has filed a Complaint dated 4-12-2020 which was received by this Commission on 5-12-2020 for not getting the information sought by him from the PIO / O/o The District Cooperative Officer, Ranga Reddy.District, Chandravihar Complex, Hyderabad – 500 001.

2. The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 27-10-2020 before the PIO requesting to furnish the information under Sec.6(1) of the RTI Act, 2005, on the following points mentioned in his application.

*P. D. N. SADANAND # 6-4-114 Sai Baba Nagar, Kattadan, Rajendranagar, R.R. Dist. Hyderabad
One Person K. Prakasham & K. Kotich has purchased
Plot no 517, In TWS Colony Area 884/1331 and he
was not given proper address that's why some
people trying to file the plot. That's why I
want his department will be asked to
trace him and tell about his plot. Please
provide his department will be asked.*

The Public Information Officer has not furnished information to the Complainant.

4. As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on **13-06-2022**.

On **13-06-2022** the case is called. The Complainant is absent. The Public Information Officer, O/o the District Cooperative Officer, Mailardevpally, Rajendranagar Mandal, Ranga Reddy District is absent.

The record goes to show that the 6(1) application was filed on 27-10-2020 and the Public Information Officer has not furnished sought information to the Complainant so far.

The Commission directs the Public Information Officer to furnish sought information to the Complainant within (15) days from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Complaint is closed.**

Issue **show cause notice** to Public Information Officer for not furnishing the sought information to the appellant within the stipulated time and for not attending hearing before the Commission. The action on the show cause notice shall be dealt with separately.
