ORDER

Sri M. RAVINDER REDDY, R/o Karimnagar District has filed a Complaint dated **03-12-2020** which was received by this Commission on **07-12-2020** for not getting the information sought by him from the PIO / O/o The Commissioner, Karimnagar Municipal Corporation, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **22-09-2020** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on **15-06-2022**.

On **15-06-2022** the case is called. The Complainant is absent. The Public Information Officer / Municipal Commissioner, Karimnagar Municipality, Karimnagar District is present.

The Public Information Officer submitted that the sought information was furnished to the Complainant on 14-6-2022 after receipt of notice from the Commission.

The Commission took a serious view in the delay of furnishing information and directs the Public Information Officer to be more careful in future while dealing with the applications filed under RTI Act, 2005.

With the above direction, **the Complaint is closed.**

Issue **show cause notice** to the then Public Information Officer for not furnishing the sought information to the appellant within the stipulated time. The action on the show cause notice shall be dealt with separately.
