ORDER

1. **Sri MOHAMMED FAROOQ AHMED, R/o Hyderabad District** has filed a Complaint dated 08-12-2020 which was received by this Commission on 09-12-2020 for not getting the information sought by him from the PIO / O/o The Assistant Engineer, Operation, Dabeerpura and Noorkhan Bazar, TSSPDCL, Hyderabad.

2. The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **28-10-2020** before the PIO requesting to furnish the information under Sec.6(1) of the RTI Act, 2005, on the following points mentioned in his application.
of R.T.I.A. of 2005.

1. **Who are the people worked at premises between Chowdhry Dairy Farm and Mallaih Dairy Farm, Noorkhan Bazar, Hyderabad on Sunday the 6th & 7th Sept.2020 upon your permission, please mention whether those workers are private or Govt. the said work has carried out with whom permission. Kindly furnish me the Certified copy of permission letter. Sir you being A.E of Dabeerpura, is a responsible officer. The Area meter reader Majid and Lineman Faheem are also responsible.**
2. **Please provide me action taken report on my complaint given to you on dated 08-09-2020 and 11-9-2020.**
3. **The Public Information Officer has not furnished information to the Complainant.**
4. **As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.**

The Complaint was taken on file and notices were issued to the parties concerned for hearing on **14-06-2022**.

On 14-06-2022 the case is called. The Complainant is present. The Public Information Officer / Assistant Engineer, TSSPDCL, Dabeerpura, Hyderabad is absent.

The Complainant submitted that he did not receive the sought information from the Public Information Officer.

The Commission directs the Public Information Officer to furnish sought information to the Complainant within (15) days from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Complaint is adjourned** for compliance by the Public Information Officer. The registry is directed to post the case for hearing after **(15) days**.
