## **ORDER**

**Sri SYED ALI HYDER, R/o Hyderabad District** filed 2<sup>nd</sup> appeal dated 11-12-2020 which was received by this Commission on 11-12-2020 for not getting the information sought by him from the PIO / O/o The Chief Executive Officer, Telangana State Waqf Board, Razzak Manzil opp Public Garden, Nampally, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o The Chief Executive Officer, Telangana State Waqf Board, Razzak Manzil opp Public Garden, Nampally, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 15-09-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

This is seek to note and full current file from **COMMITTEE SECTION** in the regard wakf to **Masjid Deendar khan** situated at sangaraddy town district in the attested manner UNDER RIGHT TO INFORMATION ACT, 2005 u/s

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 27-10-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on 19-04-2022.

On 19-04-2022 the case is called. The Appellant is absent. The Public Information Officer, O/o the CEO, T.S.Waqf Board, Nampally, Hyderabad is absent. The 1st Appellate Authority is absent.

The Public Information Officer filed a letter dated 18-4-2022 submitting that the staff of the entire Wakq Board are busy in duties for distribution of Gift packets to the Muslim community as ordered by the Government on the eve of Ramzan. Hence the Public Information Officer requested to adjourn the case after Ramzan.

In view of the above, the **Appeal was adjourned to 18-05-2022.**

**On 18-05-2022 the case is called.** The Appellant is absent. The Public Information Officer, O/o the Telangana State Wakq Board, Haj House, Nampally, Hyderabad is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the sought information is ready and is being furnished to the appellant.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

The record goes to show that the 6(1) application was filed on 19-5-2020 and the Public Information Officer has not furnished sought information to the appellant even after two years.

The Commission directs the Public Information Officer to furnish sought information to the appellant within one week from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**

Issue **show cause notice** to Public Information Officer for not furnishing the sought information to the appellant within the stipulated time. The action on the show cause notice shall be dealt with separately.
