ORDER

1. Sri RAVI KARNE, H.No.8-1-61/2C, Balaji Nagar, Manuguru Mdl, Bhadradri Kothagudem District- 507 117 has filed a Complaint dated 16-12-2020 which was received by this Commission on 17-12-2020 for not getting the information sought by him from the PIO / O/o The District Co-operative Officer, Kothagudem, Bhadradri Kothagudem District-507101.

2. The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 2-3-2020 before the PIO requesting to furnish the information under Sec.6(1) of the RTI Act, 2005, on the following points mentioned in his application.

1) భద్రాద్రి కొత్తగూడెం జిల్లా మూడుగురు మండలాలైన ప్రొద్దుటూరు సూరపర సంఘం లాం 2334 మరియు సోమలూరి ఎంత మంది వట్టూ పాస్ బుక్ లు ఉన్నాయి. వారి యొక్క పేరు, ఆఫీస్ పేరు, ఆఫీస్ నెంబర్, సర్టిఫైడ్ సింబల్ యొక్క పేరు వంటివి తెలియజేయమని ఆయన ATTESTED COPY లు ఇవ్వమని కోరాడు.

2) తెలంగాణ రాష్ట్రంలోని ప్రొద్దుటూరు సూరపర సంఘం సభ్యత్వము కొరకు ఉండవలసిన షరతులు తెలియజేయమని ఆయన కోరాడు.

3) మూడుగురు మండలాలైన ప్రొద్దుటూరు సూరపర సంఘం కింద CKCC (బిల్డింగ్ షూరింగు) 01-01-2014 నుండి 02-03-2020 వరకు షూరింగ్ ఆఫీసుకు వారి యెవరూ ATTESTED COPY ఇవ్వమని కోరాడు.

4) మూడుగురు మండలాలైన ప్రొద్దుటూరు సూరపర సంఘం కింద షూరింగ్ ఆఫీసుకు వారి యెవరూ ATTESTED COPY ఇవ్వమని కోరాడు.

5) మూడుగురు మండలాలైన ప్రొద్దుటూరు సూరపర సంఘం యొక్క 01-01-2014 నుండి 02-03-2020 వరకు షూరింగ్ ఫీజులు తెలియజేయమని ఆయన ATTESTED COPY లు ఇవ్వమని కోరాడు.

3. The Public Information Officer has not furnished information to the Complainant.
4. As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on 13-06-2022.

On 13-06-2022 the case is called. The Complainant is absent. The Public Information Officer / Assistant Registrar, O/o the District Cooperative Officer, Kothagudem District is present.

The Complainant filed affidavit through post stating that he has not received sought information from the Public Information Officer.

The Public Information Officer submitted that the sought information was furnished to the Complainant on 20-03-2020.

On perusal of information furnished it is noticed that the Public Information Officer requested the Superintendent, B-Section of their office to furnish sought information. The deemed Public Information Officer has not furnished information so far.

The Commission directs the Public Information Officer to obtain required information from concerned section and furnish the same to the Complainant within (15) days from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Complaint is closed.**

The Public Information Officer is **warned** to be prompt while dealing with application filed under RTI Act, 2005 and strictly adhere to the stipulated time limits with reference to Sec.7(1) of the RTI Act, 2005.
