ORDER

Sri RAM MOHANLAL DESAI, R/o Hyderabad District filed 2nd appeal dated 21-12-2020 which was received by this Commission on 21-12-2020 for not getting the information sought by him from the PIO / 1) O/o The Assistant Medical Officer of Health, GHMC, Circle-12, Khairtabad Zone, Mehdiapatnam, Hyderabad 2) O/o the Deputy Commissioner, GHMC, Circle-12, Khairtabad Zone, Mehdiapatnam, Hyderabad and 1st Appellate Authority / O/o the Deputy Commissioner, GHMC, Circle-12, Khairtabad Zone, Mehdiapatnam, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 08-10-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

Particulars of information required:

- [1] CC Copy of Trading License issued to the Hill Top Convection in Premises No:
10-2-317/6, Plot 6/A, Ex-Servicemen Colony, Vijay Nagar Colony, Hyderabad - 57

The Public Information Officer through letter No. 66/RTI/C12/TPS/GHMC/2020 dated 22-10-2020 furnished the sought information to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1st appeal dated 11-11-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on 20-04-2022.

On 20-04-2022 the case is called. The Appellant is present. The Public Information Officer / Deputy Commissioner, Circle-12, Mehdiapatnam, GHMC, Hyderabad is present. The 1st Appellate Authority is absent.

The appellant submitted that he has received sought information from the Public Information Officer in full with a delay of one year.

The Public Information Officer submitted that the sought information was furnished to the appellant on 30-08-2021 vide letter No.84/H&S/CIR.12/GHMC/2021.

Since information is furnished, **the Appeal is closed.**

The Public Information Officer is **cautioned** to be prompt while dealing with application filed under RTI Act, 2005 and strictly adhere to the stipulated time limits with reference to Sec.7(1) of the RTI Act, 2005.
