## ORDER

Sri MADHU GADIPALLY, R/o Warangal Urban District filed 2<sup>nd</sup> appeal dated 16-12-2020 which was received by this Commission on 21-12-2020 for not getting the information sought by him from the PIO / O/o The District Collector, Warangal Rural District and 1<sup>st</sup> Appellate Authority / O/o The District Collector, Warangal Rural District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 15-05-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

3) రవీందర్ నారు పురపాలక సంఘం పాపనాలలు, కావలిత్రయ చదివిగోటి, పురపాలక సంఘం పురపాలక సంఘం.  
4) ప్రస్తుతము ఆచనకి విలువలపై HRA క్లయమే చేస్తున్నారని వాదించినాలు.  
చరబాస్తు రుసుము: రూ..... నగదు/ఉపయోగ ప్రామాణికం/బ్యాంకు/చెక్కు/ఇంటియన్ సోఫ్టు అట్టరు/కాట్టు ప్ సాంపలు (వివరాలు).....  
సంబంధములు 2005 ప్రకారం చెల్లిస్తున్నాను. రక్షింపు ఇవ్వగలరు.  
ధన్యవాదాలు.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 22-06-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on 23-05-2022.

On 23-05-2022 the case is called. The Appellant is absent. The Public Information Officer, O/o the District Collector, Warangal Rural District is absent. The 1st Appellate Authority is absent.

The record goes to show that the 6(1) application was filed on 15-05-2020 and the Public Information Officer has not furnished sought information to the appellant so far.

The Commission directs the Public Information Officer to furnish sought information to the appellant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**

Issue **show cause notice** to Public Information Officer for not furnishing the sought information to the appellant within the stipulated time and for not attending hearing before the Commission. The action on the show cause notice shall be dealt with separately.
