ORDER

Sri NARSIMHA CHARY KALIKOTA, R/o Karimnagar District has filed a Complaint dated Nil which was received by this Commission on **29-12-2020** for not getting the information sought by him from the PIO / O/o The Tahsildar, Ramadugu Mandal, Karimnagar District in compliance of the orders of the Commission dated 19-02-2020 in Complaint No. 13795/CIC-(Peshi-2/2018/2018 with regard to his 6(1) application dated 07-12-2017:

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on **15-06-2022**.

On **15-06-2022** the case is called. The Complainant is present. The Assistant Public Information Officer / Senior Assistant, O/o the Tahsildar, Ramadugu Mandal, Karimnagar District is present.

The Complainant submitted that he did not receive the sought information from the Public Information Officer.

The representative of the Public Information Officer submitted that he has brought the information today. On perusal of the information it is observed that the ROR copy was not brought by the Public Information Officer.

The Commission took a serious view and directed the Public Information Officer to furnish complete information to the Complainant within (15) days from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Complaint is adjourned** for compliance by the Public Information Officer.
