ORDER

Sri S. SRIKANTH, R/o Karimnagar District filed 2nd appeal dated 26-12-2020 which was received by this Commission on 29-12-2020 for not getting the information sought by him from the PIO / O/o The Commissioner, Jammikunta Municipal Corporation, Karimnagar District and 1st Appellate Authority / O/o The Commissioner, Jammikunta Municipal Corporation, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 04-08-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

1. జమ్మికుంట మున్సిపాలిటీలో ఫిట్టర్ సంపత్రావు గారిని ఆ మధ్యలో సస్పెండ్ చేసినారు. దేని గురించి సస్పెండ్ చేసినారు చేసిన పైలు, మళ్ళీ విధులు ఏలా తీసుకున్నారో అయొక్క పైలు, రూపాయికి నల్ల కనెక్షన్లు ఎన్ని ఇచ్చినారు. వాటి యొక్క పూర్తి వివరాలు
 2. మున్సిపాలిటీ కార్యాలయము సంబంధించిన ఫర్నచర్ కొనుగోలు బిల్లులు.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 18-09-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on 15-06-2022.

On 15-06-2022 the case is called. The Appellant is absent. The Public Information Officer / Manager, O/o the Municipal Commissioner, Jammikunta Municipality, Karimnagar is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that part information was furnished to the appellant on 20-08-2020 and 29-08-2020.

On a perusal of the information furnished it is seen that for point no.1 the information was rejected as it was 3rd party information. For point no.2 the Public Information Officer stated that the information was not available.

The appellant asked the number of Nalla connections issued. The Public Information Officer ought to have furnished the information to the appellant.

The Commission directs the Public Information Officer to furnish sought information to the appellant within (15) days from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is adjourned** for compliance by the Public Information Officer.
