ORDER

Sri S. SRIKANTH, R/o Karimnagar District filed 2nd appeal dated 26-12-2020 which was received by this Commission on 29-12-2020 for not getting the information sought by him from the PIO / O/o The Commissioner, Jammikunta Municipal Corporation, Karimnagar District and 1st Appellate Authority / O/o The Commissioner, Jammikunta Municipal Corporation, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 31-07-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

4. తేదీ: 01.09.2017 నుండి 01-07-2020 వరకు టి.బి.ఆర్. రిజిస్ట్రర్ కాపీలు
5. పట్టణ ప్రగతికి వచ్చిన బడ్జెట్ వివరాలు, వాటిని ఖర్చు చేసిన బిల్లులు మొత్తము కాపీలు

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 18-09-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on 15-06-2022.

On 15-06-2022 the case is called. The Appellant is absent. The Public Information Officer / Manager, O/o the Municipal Commissioner, Jammikunta Municipality, Karimnagar is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that on 28-8-2020 the appellant was informed that for furnishing information to the appellant he has to pay an amount of Rs.27,540/- towards cost of information. As the appellant did not pay the amount the information could not be furnished.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

The Commission directs the Public Information Officer to furnish the information to the appellant as and when he deposits the amount.

With the above direction, **the Appeal is closed.**
