ORDER

Sri KHAJA ATHERUDDIN, R/o Karimnagar District has filed a Complaint dated 29-12-2020 which was received by this Commission on 31-12-2020 for not getting the information sought by him from the PIO / O/o The Commissioner, Karimnagar Municipal Corporation, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 20-11-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

in the matter. Also, if this requisition will I am paying RTI Act-2005

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on 15-06-2022.

On 15-06-2022 the case is called. The Complainant is absent. The Public Information Officer / Assistant City Planner, O/o the Municipal Commissioner, Karimnagar Municipality, Karimnagar is present.

The Public Information Officer submitted that part information was furnished to the Complainant on 4-2-2020. The Public Information Officer further submitted that as the Complainant has not given the house number the complete information was furnished to him. The authorized representative of the Complainant submitted that he has given the survey number.

The Commission advised the Complainant to give the house number and directs the Public Information Officer furnish the information to the Complainant within (15) days after receipt of the house number from the Complainant and report compliance to the Commission.

With the above direction, the Complaint is adjourned for compliance by the Public Information Officer.
