ORDER

Sri Pallela Devaraju, R/o Karimnagar District filed 2nd appeal dated 13-09-2021 which was received by this Commission on 13-09-2021 for not getting the information sought by him from the PIO / O/o The Mandal Revenue Officer, Kothapalli Mandal, Karimnagar District and 1st Appellate Authority / O/o The Revenue Divisional Officer, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 05-07-2021 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

The Public Information Officer through letter No. C/102/2021 dated 14-07-2021 furnished reply to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1st appeal dated 09-08-2021 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **17-05-2022**.

On 17-05-2022 the case is called. The Appellant is absent. The Public Information Officer / Naib Tahsildar, Kothapally Mandal, Karimnagar District is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the sought information was furnished to the appellant on 15-07-2021 by hand. The Public Information Officer produced copy of information furnished duly acknowledged by the appellant.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since information is furnished, **the Appeal is closed.**
