ORDER

Sri Vavilla Ramesh Goud, R/o. Suryapet District has filed a Complaint dated 31-10-2019 which was received by this Commission on 04-11-2019 for not getting the information sought by him from the PIO / O/o. the Assistant Divisional Engineer, Operation, TSSPDCL, Munagala, Suryapet District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 19-08-2019 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

1) మనగాల మండలం మైదూరిలో ఇంటిక బట్టలు సత్వర్గం సంబంధ పరిధిలో ఉన్న

2) ఇట్ట బట్టలకు ప్రత్యేకంగా మైదూరి ఎమ్మెల్యేలకు మంజూరి చేసినాకు
ఉన్న బాతరుంబ తెలిపగలకు
3) ఇట్ట బట్టలకు మంజూరి చేసిన వివరాలు వి డ్యుకొరికి చొవికగా తెలిపగలకు

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 23-08-2021.

On 23-08-2021 the case is called. The Complainant is absent. The PIO / O/o. the Assistant Divisional Engineer, Operation, TSSPDCL, Munagala, Suryapet District is absent.

The record goes to show that the 6 (1) application was filed on 19-08-2019 and the PIO did not furnish information till date.

The Commission directs the PIO to furnish the sought information to the Complainant within (10) days of the receipt of this order and submit compliance to this Commission.

The case was adjourned to 27-04-2022.

On 27-04-2022 the case is called. The Complainant is absent. The Public Information Officer / ADE, Operation, TSSPDCL, Munagala, Suryapet District is present.

The case was earlier heard and adjourned on 23-08-2021 with a direction to Public Information Officer to furnish full information to the appellant within (10) days from the date receipt of this order and submit compliance to the Commission.

The Public Information Officer submitted that the sought information was furnished to the Complainant on 25-08-2021 and 29-01-2022 by speed post.

The Complainant did not choose to attend the hearing nor filed affidavit offering his version.

She further submitted that she could not attend the hearing on 23-08-2021 as the notice sent by the Information Commission was received on 25-08-2021 as their office is shifted to new building whereas the notice was sent to the old building. She further requested to excuse for the lapse and assured that she would not repeat such lapse in future.

Since information is furnished, **the Complaint is closed.** The explanation submitted by the Public Information Officer is accepted and accordingly the further action on the Show Cause Notice against her is **dropped.**
