## ORDER

Sri Pallela Devaraju, R/o Karimnagar District filed 2<sup>nd</sup> appeal dated 05-11-2021 which was received by this Commission on 08-11-2021 for not getting the information sought by him from the PIO / O/o The District Collector, Karimnagar District and 1<sup>st</sup> Appellate Authority / O/o The District Collector, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 03-09-2021 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

3) DIS నం. HS/720/2016, తేదీ: 20-10-2016 గల కలెక్టర్ నోడల్స్ ను శ్రీ విజయం ప్రశ్నింపి.  
4) CMP.నం. 11604/Gen-GP/2016, తేదీ: 22/09/2016 గల జి.ఎస్.ఆర్. కలెక్టర్ ను శ్రీ విజయం ప్రశ్నింపి. మరియు A3 సెక్షన్ లో భాగం విను పరిశోధనం చేయమని ప్రశ్నింపి.  
దరఖాస్తు రుసుము రూ. .... నగదు / డిమాండ్ డ్రాఫ్ట్ / బ్యాంకర్స్ చెక్కు / ఇంటియస్ పోస్టల్ ఆర్డరు / క్రెడిట్ కార్డు ద్వారా (చివరాలు) క్రెడిట్ కార్డు. సమాచారం, హక్కు నిబంధనలు 2005 ప్రకారం పంపించమని ప్రశ్నింపి.  
భవిష్యత్తులో చేసినారు. ఆధారాలు శ్రీ విజయం ప్రశ్నింపి.

The Public Information Officer through Lr.No.A2/2017/2019 dated 27-09-2021 furnished the sought information to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1<sup>st</sup> appeal dated 05-10-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get complete information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on 17-05-2022.

**On 17-05-2022** the case is called. The Appellant is absent. The Public Information Officer, O/o the District Collector, Karimnagar District is absent. The Naib Tahsildar, Kothapally Mandal is present on behalf of the Public Information Officer. The 1st Appellate Authority is absent.

The representative of the Public Information Officer submitted that the sought information was furnished to the appellant on 27-09-2021 and 20-10-2021 by speed post. The Public Information Officer produced copy of information furnished along with dispatch proof.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since factual information is furnished, **the Appeal is closed.**

Issue **show cause notice** to Public Information Officer for not attending hearing before the Commission. The action on the show cause notice shall be dealt with separately.
