ORDER

Sri C. Suryanarayana, R/o Hyderabad District filed 2nd appeal dated 08-11-2021 which was received by this Commission on 11-11-2021 for not getting the information sought by him from the PIO / The Divisional Engineer, Electrical, Operation, TSSPDCL, Wanaparthy and 1st Appellate Authority / O/o The Director, Commercial, Head Office, Corporate Office,, TSSPDCL, Mint Compound, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **19-07-2021** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

The Public Information Officer through Letter No. TSSPDCL/SPIO/APIO/RTI Act/ID.Nos110,111,112/2021, D.No.217/2021 dated 26-07-2021 transferred the application U/s 6(3) to the Public Information Officer, The Divisional Engineer, Electrical, Operation, TSSPDCL, Wanaparthy for furnishing the sought information.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated **07-10-2021** before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **10-05-2022**.

On 10-05-2022 the case is called. The Appellant is present. The Public Information Officer / Divisional Engineer, Operation, TSSPDCL, Wanaparthy is absent. The 1st Appellate Authority is present.

The Appellant submitted that he did not receive the sought information from the Public Information Officer.

The Public Information Officer submitted that the factual information was furnished to the appellant on 27-10-2021.

The same matter was earlier heard in **Appeal No.14602/SIC-Dr.MA/2021** dated 27-04-2022 and disposed of by closing the appeal as factual information was furnished by the Public Information Officer.

Accordingly, the present Appeal is also **closed**.
