ORDER

Sri C.Suryanarayana, R/o Hyderabad filed 2nd appeal dated 10-11-2021 which was received by this Commission on 10-11-2021 for not getting the information sought by him from the PIO / The Divisional Engineer, Electrical, Operation, TSSPDCL, Wanaparthi and 1st Appellate Authority / O/o The Director, Commercial, Head Office, Corporate Office, TSSPDCL, Mint Compound, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **29-09-2021** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

With reference to the above, as an alternative option, under Sec.6 (1) of RTI Act, 2005, I request you to provide me the **EXTRACT COPY OF LEDGER CLOSING of the following work orders as per SI.No.127- Ledgers (F) - PERIOD OF PRESERVATION - PERMANENT**

The Public Information Officer through letter No. DEE/OP/WNP/JAO/SA/GAS/ D.No.1977/2021 dated 27-10-2021 furnished reply to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1st appeal dated **07-10-2021** before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **18-04-2022**.

On 18-04-2022 the case is called. The Appellant is present. The Public Information Officer / Divisional Engineer, Electrical, Operation, TSSPDCL, Wanaparthy is absent. The 1st Appellate Authority is absent.

The Appellant submitted that he did not receive the sought information from the Public Information Officer.

The Public Information Officer was absent and hence the Appeal was **adjourned** to **27-04-2022** on which date the Public Information Officer shall appear in person with connected records.

On 27-04-2022 the case is called. The Appellant is present. The Public Information Officer / Divisional Engineer, Operation, TSSPDCL, Wanaparthy is present. The 1st Appellate Authority is absent.

The Appellant submitted that he did not receive the sought information from the Public Information Officer.

The Public Information Officer submitted that the factual status of matter was informed to the appellant on 18-09-2021, 29-10-2021 and 11-01-2022 that the sought records pertaining to 40 years old record as per instructions every record will be kept for 10 years and after that the record will be sold out to company authorized persons.

Since factual status of the matter has been furnished, **the Appeal is closed.**
